

Diabetes Mellitus Coding Tips



HEDIS®

Exclude members who:

1. Did not have a diagnosis of diabetes in any setting, during the measurement year or the year prior to the measurement year, **and** who had a diagnosis of polycystic ovarian syndrome, gestational diabetes, or steroid-induced diabetes, in any setting during the measurement year or the year prior to the measurement year.
2. Members in hospice or using hospice services any time during the measurement year.
3. Members who died any time during the measurement year.
4. Members receiving palliative care any time during the measurement year.

Hemoglobin A1c Control for Patients With Diabetes (HBD)

Controlled — <8.0%: Submit CPT® II code lab values
Poor Control — >9.0%: Submit CPT II code lab values

CPT II 3044F, 3046F, 3051F, 3052F

Members ages 18–75 with diabetes (type 1 and type 2) who were compliant with HbA1C control (<8.0) or non-compliant (>9)

Statin Therapy for Patients With Diabetes (SPD)

Received Statin Therapy

Dispensed at least one statin medication of any intensity

Statin Adherence 80%

Remained on statin medication of any intensity for at least 80% of the treatment period.

Members ages 40–75 with diabetes who do not have clinical atherosclerotic cardiovascular disease (ASCVD)

Blood Pressure Control for Patients With Diabetes (BPD)

Controlled — <140/90: Submit CPT II code values

CPT II codes: Diastolic	Systolic:
3078F = <80 mm Hg	3074F = <130 mm Hg
3079F = 80–89 mm Hg	3075F = 130 – 139 mm Hg
3080F = >90 mm Hg	3077F = >140 mm Hg

Members ages 18–75 with diabetes (type 1 and type 2) who had BP control (<140/90 mm Hg)

Estimated Glomerular Filtration Rate (eGFR)

Urine Albumin-Creatinine Ration (uACR)

*Members 18–85 years of age with diabetes (type 1 and type 2) who received a kidney health evaluation, defined by an estimated glomerular filtration rate (eGFR) **and** a urine albumin-creatinine ratio (uACR)*
