HEDIS® Tips: Acute Bronchitis



Measure Description

Members three months of age and older who were diagnosed with acute bronchitis/bronchiolitis and were not dispensed an antibiotic prescription within three days of the visit¹

Note: Prescribing antibiotics for acute bronchitis is not indicated unless there is a comorbid diagnosis or coexisting bacterial infection (examples below). Only about 10% of cases of acute bronchitis are due to a bacterial infection, so in most cases, antibiotics will not help.

Tips to Improve HEDIS Scores

Telehealth visits are allowed for this measure:

- Includes telephone visit, e-visit, or virtual checkin (observation and ED visits as well)
- Do not prescribe antibiotics when treating acute bronchitis unless there are comorbid conditions or competing diagnoses that require antibiotic therapy.

If the member or caregiver insists on an antibiotic:

- Arrange an early follow-up visit by telehealth or re-examination (tell them to follow-up in three or more days if symptoms worsen or don't improve).
- Write a prescription for symptom relief instead of an antibiotic.
- Review bacterial infection symptoms with the member/caregiver and inform them that antibiotics will not help with viral infections. Discuss the side effects of antibiotic use.

Refer to the illness as a chest cold or lower respiratory infection and educate the member of caregiver on at-home treatment:

- Over-the-counter (OTC) medicines appropriate for the patient (such as cough, cold, pain reliever and anti-inflammatory medicines)
- Getting plenty of rest and drinking extra fluids

Submit all diagnosis codes if present on the claim/encounter for visit.
