Well-Child Visits in the First 30 Months of Life (W30)1

The percentage of members who had the following number of well-child visits with a PCP during the last 15 months

The following rates are reported:

- ► Well-child visits in the first 15 months

 Children who turned 15 months old during the measurement year six or more well-child visits
- ► Well-child visits for 15–30 months

 Children who turned 30 months old during the measurement year two or more well-child visits
- ▶ Performed January 1-December 31 of the measurement year

Well-Child Visits in the First 15 Months

Six or more well-child visits on different dates of service by the child's 15-month birthday

- ► The well-child visit must occur with a PCP, but the PCP does not have to be the child's assigned practitioner.
- Administrative-only measure (medical record/ hybrid method removed)

Well-Child Visits for Ages 15-30 Months

Two or more well-child visits on different dates of service between one day after the child's 15-month birthday and the child's 30-month birthday

- ► The well-child visit must occur with a PCP, but the PCP does not have to be the child's assigned practitioner.
- Administrative-only measure (medical record/hybrid method removed)

Child and Adolescent Well-Care Visits (WCV)

The percentage of members 3–21 years of age who had at least one comprehensive well-care visit with a PCP or OB/GYN during the measurement year

- ► The well-care visit must occur with a PCP or OB/GYN, but the practitioner does not have to be the member's assigned practitioner.
- Administrative-only measure (medical record/hybrid method removed)
- ▶ Performed January 1 December 31 of the measurement year

Weight Assessment and Counseling for Nutrition and Physical Activity for Children/Adolescents (WCC)²

The percentage of members 3–17 years of age who had an outpatient visit with a PCP or OB/GYN and who had evidence of the following during the measurement year:

- ▶ BMI percentile documentation
- ► Counseling for nutrition
- ► Counseling for physical activity

- ► An outpatient visit with a PCP or OB/GYN during the measurement year
- ► Performed January 1–December 31 of the measurement year (identified by administrative data and medical record review)

Note: The practitioner does not have to be the member's assigned practitioner.

BMI Percentile

BMI percentile during the measurement year

- ► Evaluates whether BMI percentile is assessed rather than an absolute BMI value
- ▶ Documentation must include height, weight and BMI percentile during the measurement year and **be from the same data source**.

Either of the following meets criteria for BMI percentile (only):

- ► BMI percentile documented as a value (e.g., 85th percentile)
- ▶ BMI percentile plotted on an age-growth chart

*A distinct BMI percentile is required (e.g., >99%, <1%, 0% or 100%)

*Ranges and thresholds do not meet criteria

Counseling for Physical Activity

Counseling for physical activity or referral for physical activity during the measurement year. Documentation must include a note indicating the date and **at least one** of the following:

- ▶ Discussion of current physical activity behaviors (exercise routine, participation in sports activities, exam for sports participation)
- Checklist indicating physical activity was addressed
- ► Counseling or referral for physical activity
- ► Evidence that the member received educational materials on physical activity during a face-to- face visit
- Anticipatory guidance specific to the child's physical activity
- ▶ Weight or obesity counseling

Counseling for Nutrition

Counseling for nutrition or referral for nutrition education during the measurement year. Documentation must include a note indicating the date and at least one of the following:

- ▶ Discussion of current nutrition behaviors, such as eating habits
- ► Checklist indicating nutrition was addressed
- ► Counseling or referral for nutrition education

- ► Evidence that the member received educational materials on nutrition during a face-to-face visit
- ► Anticipatory guidance for nutrition
- ▶ Weight or obesity counseling
