

# **Diabetes Coding Tips**

#### **HFDIS®**

#### Exclude members who:

- 1. Did not have a diagnosis of diabetes in any setting, during the measurement year or the year prior to the measurement year, **and** who had a diagnosis of polycystic ovarian syndrome, gestational diabetes, or steroid-induced diabetes, in any setting during the measurement year or the year prior to the measurement year.
- 2. Members in hospice or using hospice services any time during the measurement year.
- 3. Members who died any time during the measurement year.
- 4. Members receiving palliative care any time during the measurement year.

#### HbA1c Control for Patients With Diabetes (HBD)

**Controlled** — **<8.0%**: Submit CPT<sup>®</sup> II code lab values **Poor Control** — **>9.0%**: Submit CPT II code lab values

**CPT** 83036, 83037

**CPT II** 3044F, 3046F, 3051F, 3052F

Members ages 18–75 with diabetes (type 1 and type 2) who were compliant with HbA1C control (<8.0) or non-compliant (>9)

# Statin Therapy for Patients With Diabetes (SPD)

#### **Recieved Statin Therapy**

Dispensed at least one statin medication of any intensity

#### Statin Adherence 80%

Remained on statin medication of any intensity for at least 80% of treatment period.

Members ages 40–75 with diabetes who do not have clinical atherosclerotic cardiovascular disease (ASCVD)

## Blood Pressure Control for Patients With Diabetes (BPD)

**Controlled** — <140/90: Submit CPT II code values

## **CPT II codes:**

Diastolic Systolic:

3078F = <80 mm Hg 3079F = 80-89 mm Hg 3075F = 130-139 mm Hg 3080F = >90 mm Hg 3077F = >140 mm Hg

Members ages 18–75 with diabetes (type 1 and type 2) who had BP control (< 140/90 mm Hg)

Members ages 18–75 with diabetes (type 1 and type 2) who had an eye exam (retinal) performed

### Kidney Health Evaluation for Patients With Diabetes (KED)

Estimated Glomerular Filtration Rate (eGFR) CPT 80047, 80048, 80050, 80053, 80069, 82565

Urine Albumin-Creatinine Ration (uACR) CPT 82043, 82570

Members 18–85 years of age with diabetes (type 1 and type 2) who received a kidney health evaluation, defined by an estimated glomerular filtration rate (eGFR) **and** a urine albumin-creatinine ratio (uACR)
